Tio requirements	 A minimum level of B2 English is required in order to be admitted to study with Tio (equivalent to IELTS 6.0 / TOEFL 80 / CEFR B2). Sending institutions need to make sure that the level of English is sufficient. Tio can only accept exchange students from partner universities, if nominated. Non-EU students need to provide the required documents at least 2.5 months prior to the semester start in order for Tio to complete the Visa application.
Tio procedure	 Fill out the online application form which will be send directly to the student once nominated by the home university. Make sure to upload the needed documents during the application process before the set deadline. Questions about the application can be sent to the International Office (internationaloffice@tio.nl). After acceptance at Tio, students will be informed about the allocation to either Amsterdam or Utrecht. Students will also be informed about the start of the academic year. Tio expects students to participate in the complete semester. Exchange students will have to take exams on the regular dates/times, just like all other Tio students. If the semester dates at Tio do not match your own university timetable, please make sure it is possible to sit for exams either at Tio or your home university.

Study materials	 Exchange students will be provided with the needed study materials for their exchange period at Tio (books, syllabi and online materials). Please make sure to bring a laptop with you, as many of the work within the groups will be done digitally. Please make sure you always have a device with up-to-date (Windows, iOS) software and a special Anti-virus software system. Please make sure to bring a suit / Tenue de Ville to Tio, while you might need to attend masterclasses or do presentations in which a suit or TDV is required.

VISA Students / Non-EU student

VISA	Non-EU students need a VISA and Residence Permit in order to study with Tio. Tio will provide the documents and will perform the procedure for the incoming students.
	Tio is offering a full service package for Non-EU students . This package has one price and includes housing, visa application procedure, residence permit, health insurance, service fee of housing and the final deposit. Everything to be fully prepared for your period abroad!



Tio needs to comply with the rules and regulations of the Dutch Immigration Department, and therefore offers non-EU students the service package. This means we both comply with the necessary rules, can apply for your residence permit and offer you housing. It's all taken care of for you.

Please note: There are no additional fees or tuition fees for education added in the package fee. It only contains your residence permit, housing and insurance. Any leftover deposit will be refunded to the student by the end of the semester.

Please note: Students from Canada can also choose for the 'WHP': Working Holiday Permit. This is a special arrangement between the Netherlands and Canada, allowing students to study here for a cheaper visa price. Besides that students than will be free to choose their own housing and insurance. The package fee is not obligatory with a WHP. Do note: students need to take care of everything (including the visa) themselves.

Service package fee for Non-EU/EEA students

If you need a visa to study at Tio, we will help and guide you through the process. In order to successfully fulfil all the requirements as set by the Dutch immigration department, Tio has set up an 'Service package'. For a fixed price you will get housing, the VISA, Residence permit insurance and the application is done by us. We do have to ask you to pay for a full package fee upfront. Once registered at Tio you will receive an invoice.

The package prices are as follows:

When staying over during the summer (between two semesters or as an addition to the studies) the 'Summer addition' needs to be booked as well (2months, costs: € 1,700.00).

The package fee includes:

- Housing (actual costs of housing, €500.00 680.00 per month)
- Service fee housing (€ 250.00 450.00)
- Insurance (€ 250.00)
- Visa application
- Residence permit (€ 207.00)
- Deposit (remaining costs)
- <u>Please note:</u> Any leftover deposit / remainder will off course be transferred back to you / the student by the end of the semester.

Why do we need you to pay a package fee?



	A student can only apply for a visa through Tio, due to Dutch visa regulations. The amount of money needs to be transferred to Tio before Tio can apply for the visa. You will receive an invoice for the total amount once we have received your application and you have been accepted to Tio.
